General Trial Information

We will be using Agility Gate for this trial for Class Running order only. Course maps will not be sent out the evening before each trial day. The code will be 0252.

Please read your confirmation letter carefully and check your dog's AKC registration number and class entries.

Setup: There will be no setup on Thursday before the trial. The building will open at 7:00 am on Friday, October 17.

There are new mats in the annex, **all crates AND chairs must be on a mat**. Please wipe your shoes and your dog's paws when coming in if it is muddy. There is a \$10 fee for any spills on the matting payable to ASDS. Crates and chairs need to be set up as they have been in the past. We will try to have areas for crates-chairs-aisles clearly marked prior to Friday morning. If you have any questions, please ask a member of the trial committee.

The daily RV reservations are full to the brim! Other Rv's will need to make other parking arrangements.

FOOD

- There will not be a concession stand on site. There are fast food restaurants and sit-down restaurants within 5 minutes of the show site.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

- **The safety of the dogs** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the event committee, be asked to leave the show site. In such case, no refund of any fees paid will be made.
- Kansas City Golden Retriever Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
- Kansas City Golden Retriever Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against Kansas City Golden Retriever Club or any official thereof.
- **All dogs must be on leash or crated** at all times when on trial grounds except when in the designated warm-up area or competing on the course.
- Kansas City Golden Retriever Club may cancel this event in extreme weather conditions.
- Pending good weather, we anticipate many exhibitors will crate in their vehicles. Please keep the parking along the tree line open for those crating out of their cars. Easy ups are welcome and encouraged.

REFUNDS

- **No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- **No entry fee** will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.
- **Bitches in season** are not permitted in the Trial. Entry fees, less \$15.00 administrative fee for each day entered, will be refunded for bitches coming in season after the closing date. The Trial Secretary must receive written veterinarian notification by letter prior to the start of the trial.

RINGSIDE

- **Dogs may arrive** any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

- **Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required

DIRECTIONS TO THE TRIAL SITE

Please be aware that most navigation devices do not know the correct location for All Star Dog Sports! It is advised that you look at a map and find the location before trusting GPS.

The site is located south of the city of Blue Springs on Highway 7, **just south of the intersection of Hwy 7 and Wyatt Rd.**

From the North (I-70): The site is 4.8 miles south of the intersection of I-70 and Hwy 7 and immediately past Anderson Rentals.

From the South: The site is 1.4 miles north of the intersection of Hwy 7 and Colbern Rd. or 5.3 miles north of the intersection of Hwy 7 and Hwy 50 and north of LockBox Storage.
