COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

- The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made.
- The Tri-State Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
- The Tri-State Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Tri-State Kennel Club or any official thereof.
- All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

REFUNDS

- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.
- Bitches in season are not permitted to compete in Agility Trials. As such, the club will refund all but \$7 per run of the entry fee paid for bitches unable to compete for this reason upon presentation of a veterinarian certificate. TSKC will also partially refund entry fees (minus an administration fee which includes the recording and judges fee) or any dog that has become injured or ill after the closing date of the trial and cannot compete. This certificate must be presented to the Trial Secretary prior to the start of judging on the first day of the trial or cluster of trials.

RINGSIDE

- Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs
- Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

VENDORS

- VENDORS BY PERMISSION ONLY. No unauthorized vendors will be allowed on the trial site.

CRATING

• Crating will be available where designated. X-pens are allowed. There is ample room to crate six feet apart and maintain social distancing. Crates and belongings may be left overnight; however, the Tri-State Kennel Club and Lucky J Restaurant & Arena will not be responsible for any lost or damaged items left at the show site.
